Premises Registration & Renewal DUE JULY 31

Premises registration is a way to locate where livestock or dead animals are kept or congregated. Premises are listed in a computerized database with information about what species of animals are kept at any pat remains with the location

location. Each premises is assigned a number that remains with the location.

Premises registration allows for much faster traces when there is an outbreak of an animal disease or an animal-borne human disease. If we know where susceptible animals are located, we can control the disease more quickly. Premises registration is not individual animal identification.


DATCP Lifts State Order Prohibiting

The Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) announces that the statewide order prohibiting movement of poultry to all live events has been lifted. The order had been in effect since May to prevent the spread of highly pathogenic avian influenza (HPAI) in Wisconsin.

The <u>Wisconsin Youth Tractor & Machinery Safety Certification Program</u> is designed to meet requirements established by the US Department of Labor, pertaining to special provisions made for the employment of youth ages 14-15 on farms not operated by their parents. White Mold of Soybean

In Wisconsin, the first couple of weeks of July brings us a heightened awareness of white mold in soybeans, and its management. The 2021 season in Wisconsin resulted in some pockets of white mold in the state. However, now is not the time to be complacent. If the weather becomes conducive in 2022, the situation could be much different than last year.

Remember that the white mold fungus infects soybeans through open and senescing flowers, by spores that are born from small mushroom-like structures called apothecia (Fig. 1). Remember that if the bloom period gets extended due to cool weather, this can lead to an extended window for infection by the fungus. Often cool weather is a double whammy as it is good for the white mold fungus and slows down soybean crop development, thereby extending bloom.
