Any Junior Fair dairy cattle exhibitor ages between 16-19 as of January 1, 2024 may apply for the "OUTSTANDING DAIRY CATTLE YOUTH EXHIBITOR" award. The award will recognize exceptional dairy youth and will be presented at the 2024 Manitowoc County Fair. The award winner will receive a \$750 reward that can be used for college education and/or dairy show-related supplies.

Any exhibitor who wishes to apply for the "Outstanding Dairy Cattle Youth Exhibitor" must submit the attached application and questions.

The information supplied in the application and questions, along with the exhibitor's performance at the Fair and knowledge of the project as determined by an interview, will be the basis for making the award.

The application and questions (not to exceed 250 words per question) are due no later than **August 1st**. These materials should be sent to Angie Ulness, Manitowoc County UW-Extension Agriculture Educator, P.O. Box 935, Manitowoc, WI 54221-0935.

An interview of all qualified exhibitors will be held starting at 10:00 a.m. on **Saturday, during the County Fair**. Applicants will be notified prior to the fair for interview time.

Previous Winners are not eligible. Decisions of the judges are final.
